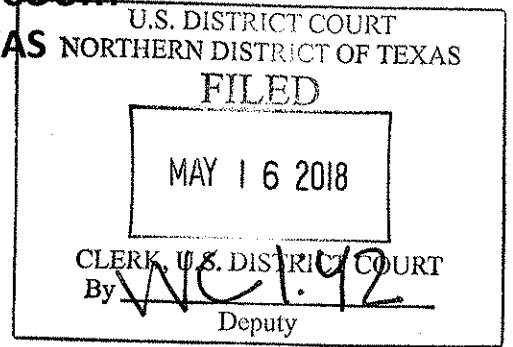

**MOTIONS FOR DEFAULT JUDGMENT UPON JOHN S. McCain AS THE NECESSARY PARTY
TO THE CASE AND TO SCHEDULE A PROVE-UP HEARING WITH BRIEF-IN-SUPPORT**

Comes now Additional Plaintiff Intervener ("API"), moving the Court to issue a Default Judgment against John S. McCain ["JSM"], stating as follows:

1 That All Interested Parties have yet to refute that "BUT FOR McCain's tortious Breach of Trust" previously proffered with "specificity & particularity", the Instant Case would be Moot, saving US Taxpayers "tens of millions (\$\$)", including infliction of Duress;

2 That [JSM] intentionally, with malice & forethought, perpetrated the said 'ultra vires' Act upon US Taxpayers causing irreparable harm, thus qualifying for the "BIVENS Action" for Reparations/Restitution to be determined @ a PROVE-UP HEARING;

3 That on **April 30, 2018**, [JSM] was delivered NOTICE via USPS CERTIFIED MAIL, yet has Failed to REPLY under the required NOTICE requirement, thus is in Default; (enclosed)

4 That on **May 9, 2018**, [JSM] again intentionally interfered with President Trump's [CIA Nominee, Gina Haspel]; aka a) to enter or appear as an irrelevant or extraneous feature or circumstance; b) to come in or between by way of hindrance or modification; c) to become a third party to a legal proceeding begun by others for the protection of an alleged interest. 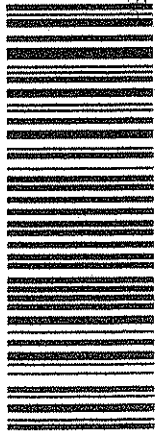
