DECLARATION OF MARK A. PETERSON

I, Mark A. Peterson, declare as follows:

1. I have personal knowledge of the matters stated in this declaration.
2. This is filed in support of Plaintiffs' Motion for Class Certification.
3. I graduated from Marquette Law School in 1975 and have been a member of the Wisconsin bar since that time. I have also been a member of the Colorado bar since 2002. I am also admitted to the U.S. District Courts for the Eastern and Western Districts of Wisconsin, the U.S. Seventh and Tenth Courts of Appeal, and the U.S. Supreme Court.
4. I am a Certified Civil Trial Specialist as determined by the National Board of Trial Advocacy. I have held that certification since 1994.
5. I have served as lead counsel in the following cases involving civil rights and disability law:

Oconomowoc Residential Programs, Inc. v. City of Greenfield, 23 F.Supp.2d 941 (E.D. Wis. 1998). Americans with Disabilities Act and Fair Housing Act - group home zoning.
