We are writing in response to the Court's adjournment of the final fairness hearing in this matter to June 27, 2019, which was entered on May 14, 2019.

On May 7, 2019, the Court adjourned the fairness hearing in this matter from May 9, 2019 to May 17, 2019. Counsel for plaintiff had a conflict with the new date and, on consent, informed the Court, on May 9, that counsel for all parties were available on June 21, 2019, a date after the trial I will be handling shortly in Delaware. The Court then granted plaintiff's counsel request for an adjournment, but set the date for June 27, 2019. Unfortunately, I and my colleague, Maria H. Keane, have previously
