MOTION

Plaintiffs-Appellees the City and County of San Francisco and County of Santa Clara ("Plaintiffs" or "Counties"), and Defendants-Appellants U.S. Citizenship and Immigration Services; Department of Homeland Security; Kevin McAleenen, Acting Secretary of Homeland Security; and Kenneth T. Cuccinelli, in his official capacity as Acting Director of U.S. Citizenship and Immigration Services ("Defendants-Appellants" or "Defendants") jointly move pursuant to Circuit Rule 31-2.2(b) for an order extending the briefing schedule.

According to this Court's November 1, 2019 order, Dkt. 2, Defendants-Appellants' Opening Brief and Excerpts of Record are currently due on November 27, 2019; the Counties' Answering Brief is due December 26, 2019; and Defendants-Appellants' Optional Reply Brief is due January 9, 2020. The parties jointly request an extension of the briefing schedule as follows:

- Defendants' Opening Brief & Excerpts of Record due December 4, 2019;
- Counties' Answering Brief due January 16, 2020;
- Defendants' optional Reply Brief due February 6, 2020.

Good cause exists for this request in light of the holiday schedule, counsels' obligations in other matters, and pre-existing vacations plans, as discussed in the following section.

SUMMARY OF THE CASE AND ISSUE ON APPEAL

This case concerns the validity of regulations issued by the Department of Homeland Security (DHS) governing "public charge" determinations.

Under the Immigration and Nationality Act (INA), the federal government may deny a visa, admission, or adjustment of status to an individual if it determines that person is "likely at any time to become a public charge." 8 U.S.C. § 1182(a)(4)(A). On August 14, 2019, DHS issued a final rule entitled "Inadmissibility on Public Charge Grounds," interpreting that provision. 84 Fed.

Reg. 41,292 (Aug. 14, 2019) ("Final Rule" or "Rule"). Plaintiffs challenge the rule on multiple grounds. Defendants appeal from the district court's order, issued October 11, 2019, granting a preliminary injunction prohibiting application or enforcement of the Final Rule within the City and County of San Francisco and the County of Santa Clara (as well as within the States of California, Oregon, and Maine, the Commonwealth of Pennsylvania, and the District of Columbia, which are the plaintiffs-appellants in the related case No. 19-17214). Defendants filed their notice of appeal on October 30, 2019. On November 1, 2019, this Court issued an order setting the briefing schedule in this appeal. Dkt. 2.

GOOD CAUSE EXISTS TO GRANT THE MODIFICATION

Under the briefing schedule set by this Court, Defendants' Opening Brief and Excerpts of Record are due December 4, 2019, and the Counties' Answering Brief is due the day after Christmas, on December 26, 2019. Substantial need exists to extend this deadline. Several major holidays—including Thanksgiving, Hanukkah, and Christmas—fall within the 4 weeks currently allotted to the Counties to prepare their brief. In addition, most of the lawyers representing the Counties in this matter are scheduled to be on vacation from December 21 through December 27, 2019, making a December 26 filing particularly challenging.

Moreover, counsel for plaintiffs anticipate having multiple deadlines in other cases during early December, including opposing a demurrer in San Francisco Superior Court, assisting with preparation for a Ninth Circuit appellate argument scheduled for December 2, and drafting a petition for rehearing en banc due to the DC Circuit Court of Appeals on December 13.

Counsel for Defendants likewise have multiple deadlines in other cases, including briefs in *National Women's Law Center v. Office of Management & Budget*, No. 19-5130 (D.C. Cir.) (filed Nov. 15, 2019); *Zukerman v. U.S. Postal Service*, No. 19-5168 (D.C. Cir.) (due Nov. 18, 2019); *Karem v. Trump*, No. 19-

5255 (D.C. Cir.) (due Nov. 22, 2019); and *Schoenberg v. FBI*, No. 19-55696 (9th Cir.) (due Nov. 27, 2019).

Lastly, the parties have coordinated the proposed schedule here with the major, dispositive briefing deadlines in this matter in the district court. The proposed extension ensures the parties will have sufficient time and resources to adequately address the complex, novel questions in both forums.
