 - 6 • **April 6, 2020:** Amicus briefs filed in support of Plaintiffs' motion.
 - 7 • **April 20, 2020:** Defendants to file in lieu of an answer, a combined response to
8 Plaintiffs' motion for summary judgment and a cross-motion for summary judgment
9 (not to exceed 50 pages).
 - 10 • **April 27, 2020:** Amicus briefs filed in support of Defendants' motion.
 - 11 • **May 4, 2020:** Plaintiffs to file a combined response to Defendants' cross-motion for
12 summary judgment and reply in support of Plaintiffs' motion for summary judgment
13 (not to exceed 30 pages).
 - 14 • **May 26, 2020:** Defendants to file a reply in support of their cross-motion for summary
15 judgment (not to exceed 20 pages).
 - 16 • **June 4, 2020:** Hearing on the cross-motions for summary judgment at 9:30 a.m. in
17 Courtroom ¹¹~~5~~^B, 15th Floor or at the Court's earliest convenience.
 - 18 • **Note:** On March 20, 2020 Defendants provided Plaintiffs with a certified copy of the
19 Administrative Record.
