**JOINT STATUS REPORT**

Pursuant to this Court’s October 23, 2017 Order, Dkt. 17, Health Net, Inc., and the United States of America respectfully submit this Joint Status Report following the Federal Circuit’s scheduling of argument in *Land of Lincoln Mutual Health Insurance Company v. United States*, No. 17-1224, and *Moda Health Plan, Inc. v. United States*, No. 17-1994. On November 17, 2017, the Federal Circuit scheduled argument in these cases for January 10, 2018.<sup>1</sup>

As the Federal Circuit has scheduled oral argument less than 45 days from the filing of this report, the parties request that this Court continue the stay of proceedings in this case through argument in *Land of Lincoln* and *Moda*. The parties shall submit another Joint Status Report by January 31, 2018 (within 21 days after argument in those two cases), proposing a schedule for further proceedings.
