JOINT STATUS REPORT

On May 7, 2020, the Court lifted the stay in this case and directed the Parties to file a joint report by May 29, 2020 updating the Court on proposed next steps in light of the United States Supreme Court’s April 27, 2020 opinion in *Maine Community Health Options v. United States*, No. 18-1023, 590 U.S. --- (2020) (Docket 42).

The Parties respectfully request that the next joint status report in this case be due on June 12, 2020.

Counsel for Defendant has advised counsel for Plaintiff that by June 12, 2020, the United States may not have completed its internal analysis and may not have yet formulated a position on the proposed next steps to be taken in this case, but will be prepared to provide a status report at that time. In the interim, the Parties will continue their ongoing discussions exploring both consensual resolution and continued litigation, if necessary.
