**JOINT STATUS REPORT**

Pursuant to this Court’s February 28, 2019 Order (ECF No. 10), the parties submit this joint status report regarding the status of *Sanford Health Plan v. United States*, No. 19-1290 (Fed. Cir.) (*Sanford*) (consolidated with *Montana Health CO-OP v. United States*, No. 19-1302 (Fed. Cir.)).<sup>1</sup> These consolidated appeals are fully briefed, as are the companion cases, *Community Health Choice, Inc. v. United States*, No. 19-1633, and *Maine Cmty. Health Options v. United States*, No. 19-2102. Oral argument at the Federal Circuit has been scheduled for January 9, 2020.

The parties respectfully request that this case continue to be stayed pending the Federal Circuit’s resolution of *Sanford* and *Montana*, and their companion appeals.
