ORDER FOR FINAL JUDGMENT

Pending before the court is the parties’ Stipulation for Entry of Judgment, filed yesterday, June 29, 2020. The Stipulation would finally resolve this case based upon the Supreme Court’s decision in *Maine Community Health Options v. United States*, __ U.S. ___, ___, ___, 140 S.
