**JOINT STATUS REPORT**

The parties respectfully submit this Joint Status Report pursuant to the Court's May 13, 2020 Order (Doc. No. 55) granting in part the Defendant's request for additional time and ordering the parties to report by June 12, 2020 the risk corridors damages amounts the Government owes to Plaintiff for CY 2014, CY 2015 and CY 2016 by stipulation if possible, or explaining any discrepancy.

The parties have agreed upon and will stipulate to the total amount of risk corridors damages the Government owes Plaintiff for CY 2014, CY, 2015 and CY 2016. Pursuant to this Court's May 13, 2020 Order, the parties jointly will file a stipulation requesting that the Court enter final judgment in Plaintiff's favor as to that agreed-upon total risk corridors damages amount within 5 days.<sup>1</sup>
