**JOINT STATUS REPORT**

The parties respectfully submit this Joint Status Report pursuant to the Court’s May 13, 2020 Order (Doc. No. 34) granting in part the Defendant’s request for additional time and ordering the parties to report by June 12, 2020 the risk corridors damages amounts the Government owes to Plaintiffs for CY 2016, by stipulation if possible or explaining any discrepancy. As the Court stated, “[t]his amount will be added to the \$52,371,915.80 risk corridors amounts the parties previously stipulated are the ‘final damages’ for CY 2014 and CY 2015.” Doc. No. 34.

The parties have agreed upon and will stipulate to the total amount of risk corridors damages the Government owes Plaintiffs for CY 2014, CY, 2015 and CY 2016. Pursuant to this Court’s May 13, 2020 Order, the parties jointly will file a stipulation requesting that the Court enter final judgment in Plaintiffs’ favor as to that agreed-upon total risk corridors damages amount within 5 days. Entry of final judgment in this total damages amount will finally resolve all of Plaintiffs’ risk corridors claims in both Case No. 17-097 and Case No. 18-333.<sup>1</sup>
