JOINT STATUS REPORT

By Order of July 6, 2020, the Court directed the parties to file a stipulation for entry of judgment by July 13, 2020 (ECF No. 28), and if an agreement has not been reached and a stipulation for entry of judgment has not been filed, the parties were required to file a joint status report by that date.

In accordance with the Court’s Order, the parties have been continuing to work together to attempt agreement on a stipulation for entry of judgment on the risk corridors claims.
