1 In an August 30, 2019 minute order, the Court instructed the parties to “notify [the Court]
2 within 24 hours of any substantive development related to the injunction” issued “by the Eastern
3 District of Pennsylvania and affirmed by the Third Circuit.” On July 8, 2020, the Supreme Court
4 reversed and remanded the Third Circuit’s decision upholding the injunction. *Little Sisters of the*
5 *Poor v. Pennsylvania*, No. 19-431 (S. Ct. July 8, 2020) (available at
6 https://www.supremecourt.gov/opinions/19pdf/19-431_5i36.pdf). According to this Court’s
7 January 22, 2020 minute order, the Parties must file “a joint status report within ten days of the
8 Supreme Court’s opinion,” or July 18, 2020.
