## **ORDER**

On September 17, 2020, the parties filed a stipulation for entry of judgment to resolve the risk corridors claims of the plaintiffs in this case. ECF No. 15. The parties agree that the Supreme Court's decision in Maine Community Health Options v. United States, 140 S. Ct. 1308 (2020), entitles plaintiffs to damages totaling \$312,574,632.57 for non-payment under section 1342 of the Patient Protection and Affordable Care Act, Pub. L. No. 111-148 (2010).

The Court therefore **ORDERS** the clerk to enter judgment in favor of the plaintiffs in the amounts specified in Exhibit 1 on Count I of the Complaint, ECF No. 1. The Court further **ORDERS** that Counts II and III of the Complaint, ECF No. 1, be dismissed with prejudice.
