4. The parties subsequently asked this Court to maintain the stay until the period to seek rehearing or Supreme Court review in *Texas I* lapses, *see* ECF No. 35, and the Court entered an order maintaining the stay and ordering the parties to submit a status report within 30 days following the lapse of the period to seek rehearing or Supreme Court review in *Texas I*, *see* ECF No. 36.

5. Plaintiffs filed a petition for rehearing *en banc* with the Fifth Circuit on September 14, 2020. The Fifth Circuit requested that Defendants file a response by October 15, 2020, and subsequently extended the deadline to November 16, 2020

WHEREFORE, the Parties respectfully request that the Court maintain the stay in this case until 30 days after all appellate avenues have been exhausted in *Texas I*.
