JOINT STATUS REPORT

Pursuant to this Court’s January 25, 2021 Order (ECF No. 14), the parties submit this joint status report. The Order granted the parties’ request to continue the stay in this case until the Federal Circuit’s judgments in *Maine Community Health Options v. United States*, No. 19-2102 (Fed. Cir.) and *Community Health Choice, Inc. v. United States*, No. 19-6333 (Fed. Cir.) become final and non-appealable, or the Supreme Court resolves any petition for a writ of certiorari, whichever is later. The Order further required the parties to submit a joint status report today, and every 30 days thereafter, proposing further proceedings.

At this point, the deadline to file a writ of certiorari in *Maine Community* and *Community Health* is still running, and no writ of certiorari has been filed. As such, the parties will file another joint status report within 30 days proposing further proceedings in this case.
