JOINT STATUS REPORT

Pursuant to this Court’s January 25, 2021 Order (ECF No. 16), the parties submit this joint status report. The Order granted the parties’ request to continue the stay in this case until the Federal Circuit’s judgments in *Maine Community Health Options v. United States*, No. 19-2102 (Fed. Cir.) and *Community Health Choice, Inc. v. United States*, No. 19-1633 (Fed. Cir.) become final and non-appealable, or the Supreme Court resolves any petition for a writ of certiorari, whichever is later. The Order further required the parties to submit a joint status report every 30 days, proposing further proceedings.

At this point, petitions for a writ of certiorari have been filed in *Maine Community and Community Health* (joint petition) and *Common Ground Health Cooperative v. United States*, No. 20-1286 (Fed. Cir.). As such, the parties respectfully request a continuance of the stay in this case pending the Supreme Court’s resolution of those petitions. The parties further propose that the Court order that the next joint status report be filed within 30 days of such resolution.
