Dear Mr. Harris:

The Court granted writs of certiorari in the above-captioned cases on February 22, 2021, and consolidated the cases for briefing and oral argument. On March 8 and 12, 2021, respectively, two groups of proposed intervenors filed motions to intervene in this Court. On March 12, 2021, the parties jointly stipulated to dismiss the cases pursuant to Rule 46.1. On April 1, 2021, the Court granted the respective petitioners' requests to extend the time to file their opening briefs to May 6, 2021. On April 26, 2021, the Court issued an order directing the filing of a letter brief by the government by May 3, 2021, with any responses by the non-federal parties and proposed intervenors due by May 10, 2021. Due to the pendency of the parties' joint stipulations to dismiss and the Court's order regarding letter briefs, all petitioners respectfully request, under Rule 30.4 of the Rules of this Court, an extension to and including June 3, 2021, within which to file their opening briefs and a joint appendix. I am authorized to state that all petitioners join in this request and that all respondents consent to this request.
