DEFENDANT ONESHARE HEALTH, LLC'S AMENDED NOTICE OF APPEAL

On May 14, 2021, Defendant ONESHARE HEALTH, LLC, f/k/a Unity Healthshare, LLC, gave notice, pursuant to 9 U.S.C. § 16(a)(1)(B), Fed. R. App. P. 3 and 4, and Tenth Circuit Rule 3.1, that it appeals to the United States Court of Appeals for the Tenth Circuit from the April 16, 2021 Order (ECF No. 67) denying Defendants' Combined Motion to Compel Arbitration (ECF No. 50), together with all interlocutory orders and rulings that produced that Order. The appeal has been docketed by the Tenth Circuit as No. 21-1186.

Pursuant to Fed. R. App. P. 4(a)(4)(B)(ii),¹ Defendant ONESHARE HEALTH, LLC, f/k/a Unity Healthshare, LLC, amends its notice of appeal to additionally and expressly include
