Dear Judge Dorsey:

I am writing to you in regards to the above-styled action. I received notification of said action by our State Attorney General, Christopher Carr's office on August 14, 2021. I felt it necessary to write to you to let you know that I have a claim against Sharity Ministries. I was a participant in their scam from June 2020 until March 31, 2021. Most of my bills went unpaid by Sharity in spite of the fact that the claims were approved. If necessary, I can provide you with copies of bills, correspondence from Sharity, and a bookkeeping record of what I have had to pay since I found out about this scam.

I do not currently have a lawsuit against the company, but am waiting to find out when I can join in the class action lawsuit in Georgia. From what I understand from the attorney in the action, it may be as much as a year before Alieria/Trinity/Sharity has their appeal heard before the district appellate court, and could run longer if the discovery period begins.

I would appreciate information on how the bankruptcy is progressing and if my claim is of any consequence to that procedure. I was a paralegal for many years, so I do have a level of understanding of the court process. I look forward to hearing from your office soon.
