STIPULATION AND ORDER RE:
SETTLEMENT CONFERENCE
DEADLINE

I. STIPULATION

The parties by and through their counsel hereby propose that the deadline for settlement conference contained in the Order Re: Trial Date and Related Dates (Dkt. No. 86 as amended by Dkt. No. 109) be amended for good cause. The parties' counsel have met and conferred and agree that mediation in mid to late July would be more fruitful than a settlement conference before June 16, 2023. 
II. ORDER
