JOINT STATUS REPORT

JOINT STATUS REPORT

Pursuant to the Court's order of June 26, 2023, ECF 42, the parties respectfully submit this Joint Status Report.

Cross motions for summary judgment remain pending in the consolidated cases of *Texas Medical Association v. U.S. Department of Health and Human Services*, No. 22-cv-450 (E.D. Tex.) (lead case) ("*TMA III*"), and *LifeNet, Inc. v. U.S. Department of Health and Human Services*, No. 22-cv-453 (E.D. Tex.) ("*LifeNet III*"). Briefing concluded in those cases on April 14, 2023. *TMA III* at ECF 56. The Eastern District of Texas heard argument on April 19, 2023. *TMA III* at ECF at 57-60.

Cross motions for summary judgment also remain pending in *Association of Air Medical Services v. U.S. Department of Health and Human Services*, No. 21-cv-3031-RJL (D.D.C.) (lead case) ("*AAMS*"). After those motions were briefed, the U.S. District Court for the District of Columbia heard argument on March 21, 2022. *AAMS* at ECF 57. At the court's request, the parties filed supplemental post-hearing briefing on April 4, 2022. *AAMS* at ECF 58-60. On September 30, 2022, the Association of Air Medical Services and the defendants stipulated to dismissal of Count I of the Association of Air Medical Services' complaint, which had challenged aspects of *Requirements Related to Surprise Billing; Part II*, 86 Fed. Reg. 55,980 (Oct. 7, 2021) ("*Interim Final Rule Part II*"). *AAMS* at ECF 79. The Association of Air Medical Services' other claims remain pending before the court and subject to the cross motions for summary judgment.

The Eastern District of Texas granted summary judgment in *Texas Medical Association v. U.S. Department of Health and Human Services*, No. 22-cv-372 (E.D. Tex.) (lead case) (*TMA II*), and *LifeNet, Inc. v. U.S. Department of Health and Human Services*, No. 22-cv-373 (E.D. Tex.) ("*LifeNet II*"), on February 6, 2023. *TMA II* at ECF 99. Defendants filed a notice of appeal to the Fifth Circuit on April 6, 2023. *TMA II* at ECF 101. Defendants-Appellants filed their opening brief

on July 12, 2023. *Texas Med. Ass'n v. U.S. Dep't of Health & Hum. Servs.*, No. 23-40217 (5th Cir.), at ECF 35. Plaintiffs-Appellees' response brief is due September 11, 2023. *Id.* at ECF 60, 62.
